Millions Could Miss Sudan Elections

Millions of voters could be left out of Sudan's first elections in 24 years because of a failure of authorities to persuade more people to register for the poll, international observers reported to *Reuters*. International observers from The Carter Centre said they were concerned poor publicity over the process had already hit the number of people registering to vote, warning some states might sign up fewer than half of eligible voters. Report urges sanctions against Sudan ruling party

A report recently released by the Enough Project, an anti-genocide group, blamed the violence in Darfur on the ruling National Congress Party (NCP) of Sudanese President Omar Hassan al-Bashir, who was indicted in March by the International Criminal Court for suspected war crimes in Sudan's remote western region of Darfur. The report called for sanctions. The head of Save Darfur, a separate coalition of more than 180 religious, political, and human rights organizations, backed the main conclusions of the Enough Project report. U.N. earmarks \$1.9 billion for 2010 Sudan humanitarian work

The global body wants \$7.1 billion. Only \$1.9 billion of the funds are earmarked for its operations in Sudan next year, down from \$2.2 billion it asked for in 2009. Aid groups and U.N. agencies are responsible for meeting the basic needs of millions of Sudanese in the south and west of the country, where years of ethnic conflicts have led to widespread displacement and poverty. 'Genocide-free' measure rejected at American Funds

Shareholders at American Funds have rejected a measure that seeks to screen out investments possibly linked to genocide in international hot spots like Sudan's Darfur region. The proposal came before shareholders at 16 of American Funds' 30 mutual funds. It needed a majority to pass. An American Funds spokesman says the most support at any of the funds where ballots were counted was about 12 percent. But each measure has fallen far short of majority support. American Funds is among the biggest fund families with about \$900 billion. It is privately owned by Los Angeles-based Capital Group. Sudan delays elections

The April 5, 2010 election in Sudan will be delayed. Election officials have faced huge logistical challenges in rolling out the first multiparty polls in 24 years in Sudan. Sudan's National Elections Commission stated that it was extending voter registration across the country, because of a late start in some areas and appeals for an extension from some political parties.
