GUIDELINES FOR APPLICANTS APPLICATION DEADLINE APRIL 16, 2010

ELIGIBILITY: Junior/Senior undergraduate students or graduate students whose legal residence is in Miami-Dade County, FL, and who are or will be enrolled in a professional degree program in Jewish Education or Jewish Communal Service.

REQUIREMENTS: Completed applications, together with supporting materials, must be received at the address below no later than April 16, 2010. Applications will not be accepted for consideration unless required materials are attached. Letters of recommendation are to be attached to the application.

Supporting materials must include the following:

- Two photographs.
- Three letters of recommendation, of which one must be from the applicant's major field of study at the University currently attending, and one from a Rabbi or a leader of the Jewish community in which the applicant resides.
- Compose a concise essay detailing your family background, Jewish education, professional experience, involvement in community and religious organizations, and your career goals insofar as they relate to future participation as a leader or professional worker in Jewish community life.
- Transcripts from all post-secondary schools attended, to be sent directly by the record custodian to Ellen Goldberg, Greater Miami Jewish Federation, FJP Silverman/Gorn Scholarship Funds, 4200 Biscayne Boulevard, Miami, FL 33137.
 - It will be the responsibility of the awardee to report his or her academic progress at regular intervals and have transcripts sent at the end of each grading period to the above contact.
- In addition, an interview may be required.

NOTIFICATION: Applicants will be notified of the outcome of their applications in late spring.
