GENERAL VOTER INFORMATION

- Eligible citizens can register to vote online: Register to Vote In Florida
- Voters begin receiving mail-in ballots: Monday, October 3, 2022
- Voter registration and party affiliation deadline: Tuesday, October 11, 2022
- Early Voting Period: Monday, October 24, 2022-Sunday, November 6, 2022
- Mail-In Voting Deadline: Saturday, October 29, 2022
- Find your voter information (sample ballots, voting precinct, request ballots):
 Miami-Dade County Voter Look Up Information
- When voting at any voting location, whether at an early voting site or on Election Day, a current and valid identification with your name, photograph and signature is required. **Click here** for a list of acceptable forms of identification.
- Note: While a voter information card is not required to vote, it can help expedite the voting process. If you lack a proper ID, you may have to vote on a provisional ballot.
- Please fill out the entire ballot. The Ballot Amendments may be the last items to appear on your ballot.
- If you registered to vote recently and you find that your name is not in the registration book, do not leave. First, ask an elections poll worker if there is a supplemental registration list. Second, ask the election worker to call the Miami-Dade County Elections office and issue you a provisional ballot.

PROPOSED STATE CONSTITUTIONAL AMENDMENTS

No. 01 Limitation on Assessment of Real Property Used for Residential Purposes

Description: "Proposing an amendment to the State Constitution, effective January 1, 2023, to authorize the Legislature, by general law, to prohibit the consideration of any change or improvement made to real property used for residential purposes to improve the property's resistance to flood damage in determining the assessed value of such property for ad valorem taxation purposes."

No. 02 Abolishing the Constitution Revision Commission

Description: "Proposing an amendment to the State Constitution to abolish the Constitution Revision Commission, which meets at 20-year intervals and is scheduled to next convene in 2037, as a method of submitting proposed amendments or revisions to the State Constitution to electors of the state for approval. This amendment does not affect the ability to revise or amend the State Constitution through citizen initiative, constitutional convention, the Taxation and Budget Reform Commission, or legislative joint resolution."

No. 03 Additional Homestead Property Tax Exemption for Specified Critical Public Services Workforce

Description: "Proposing an amendment to the State Constitution to authorize the Legislature, by general law, to grant an additional homestead tax exemption for nonschool levies of up to \$50,000 of the assessed value of homestead property owned by classroom teachers, law enforcement officers, correctional officers, firefighters, emergency medical technicians, paramedics, child welfare services professionals, active duty members of the United States Armed Forces, and Florida National Guard members. This amendment shall take effect January 1, 2023."
